

# Cookie Policy

This Cookie Policy explains what cookies are, how we use them on the Immersive Labs website (the **Website**) and on the Immersive Labs Platform (the **Platform**), and your options for controlling them. Our Website and Platform use cookies to distinguish you from other users and help us to deliver a good browsing experience, whilst also allowing us to improve their overall quality. By continuing to browse the Website or Platform, you are agreeing to our use of cookies.

## 1. WHAT ARE COOKIES?

---

Cookies are small pieces of information that include a unique reference code that a website transfers to your device to store and sometimes track information about you. A number of cookies we use last only for the duration of your web session (“**session cookies**”) and expire when you close your browser. Other cookies are used, for example, to remember you when you return to the site and will last for longer (“**persistent cookies**”). Cookies are uniquely assigned to your device and are sent back to the originating website on each subsequent visit (if they last longer than a web session) or to another website that recognizes that cookie.

Our Platform and Website use first-party and third-party cookies to provide services and resources you may have requested during your navigation. We classify these cookies into the following categories:

- Strictly necessary cookies as the ones to provide the service, application, and other essential functionalities of our Website or Platform.
- Functional cookies as the ones to provide enhanced performance for some Website or Platform resources and services as well as sometimes to adopt a higher level of personalization on user experience.
- Performance cookies as the ones to provide quantitative measurement of our Website and Platform and their resources used for purposes like troubleshooting and analytics.
- Targeting cookies as the ones to provide behavioral advertising and re-marketing of analytical data.

	_hjSession_2393129	First-party	A few seconds	A cookie that holds the current session data. This ensures that subsequent requests within the session window will be attributed to the same session.

	__hssc	First-party	A few seconds	Used for website analytics.

	_hjAbsoluteSessionInProgress	First-party	A few seconds	This cookie is used to detect the first pageview session of a user.
